Content	Animal Physiology is a subject with central position in Biology. The study is focused on the function of organs in a system organ and its interaction with other system organs within the body, including coordination systems (nervous and hormonal), connecting systems (digestive, respiratory, and excretion), and complementary systems (muscle and glands). It is emphasizes on understanding the basic concepts of physiology (homeostasis) and principles of action mechanism to regulate the body system in normal condition. This course also study the comparison on various groups of animals ranging from invertebrates, vertebrates, and humans.
